# **Assess the Risks**

#### Assess the environment

### **Coral Bay**

The location chosen for the camp (Coral Bay) is a suitable environment to carry out adventure and outdoor activities. This environment poses a low level of risk to students who are following directions and obeying clear rules, however it is still an uncontrolled natural location that has an inherent risk value.

Coral Bay is part of the Ningaloo Marine Park environment that is managed and controlled by the Department of Environment and Conservation to lower the dangers and risks that may be present in an unmanaged area of land.

Coral Bay settlement is a very small settlement that houses approximately 150 permanent residents and approximately two thousand tourists a week during peak periods.

Ningaloo Reef Adventure Camp (NRAC) runs approximately 30 camps a year catering to over 1000 children, with all camps based in Coral Bay. They are a very experienced operation, which came highly recommended.

Accommodation with Ningaloo Reef Adventure Camps is in a private area with all facilities such as safari camp tents, a fully provisioned commercial kitchen, private ablution blocks, and large recreational area.

Ningaloo Reef Adventure Camps Public Liability Insurance covers the students camping whilst at the village. Ningaloo Reef Adventure Camps public liability insurance policy covers the students for all activities they conduct and organise, including subcontractors and third party providers they utilise in the provision of these activities.

Ningaloo Reef Adventure Camps supplies all meals for the duration of the camp, all activities for the duration of the camp and all accommodation for the duration of the stay.

### **Risk Analysis**

A risk analysis has been conducted for the above locations and the following items were identified as possible issues. Each risk has then been addressed with appropriate actions to remove, minimise or contain the possible risks.

## Water Hazards

• In closed water environments Departmental regulations stipulate one qualified supervisor <a href="supervising">supervising</a> for every 32 students in the water and one qualified supervisor <a href="supervising">supervising</a> for every 22 students. A certain number of non-qualified supervisors are needed dependant on the number of participants in the water.

- In open water environments departmental regulations stipulate one qualified supervisor for every 12 students in the water. as well as these supervisors. A certain number of non-qualified supervisors are needed dependant on the number of participants in the water.
- Coral Bay and surrounding areas, such as the lagoon are safe, closed water-based environments that contain no very deep water, dumping waves, rips or strong currents. Areas selected for swimming do not exceed 100 metres of shoreline, are well defined and have been used by many swimmers and snorkellers of all ages.
- Safe entry and exit locations will be specified for each swimming activity and shown to the students before they enter the water.
- All snorkelling equipment will be supplied.
- Any marine vessels used for activities comply with the Department of Planning and Infrastructure requirements. Ningaloo Reef Adventure Camp can provide the necessary insurance documentation of the marine vessels used.
- Ningaloo Reef Adventure Camps supply employs head counts upon entering and exiting the water, safety check systems of buddies and supervisors patrolling the designated areas.

NRAC employs the services of qualified skippers, environmental scientists, dive masters, chefs and camp directors. Copies of all qualifications and certificates can be supplied to ensure compliance with DET policy requirements.

- Certificate of Liability <u>Ningaloo Reef Adventure Camps</u>: covers camping, food/drink, beach & bushwalking, dancing, orienteering, star gazing, guided night spotlighting, reef walking, sightseeing, bush regeneration, beach games, night games, non-contact games, educational activities, swimming and snorkelling off the beach, subcontractors/third party providers conducting boating, guided sea kayaking, fishing, swimming, snorkelling, coral viewing and marine interaction tours.

# **Establish Supervision Strategies**

Ningaloo Reef Adventure Camps applies the following supervision and safety strategies –

- a) Students are continually in view of supervisors.
- b) Supervisors restrict students to designated areas.
- c) Head counts are implemented entering water, exiting water and during activity.
- d) Supervisors patrol designated areas.
- e) Safety check systems implemented buddy and check systems, water checks, safety stops.
